

Cressy Tennis Club

- 1 The name of the club shall be the Cressy Tennis Club.
- 2
 - (A) The officials of the club shall consist of 7 members President Chairman Capt., Vice Capt. Ladies Vice Capt. Secretary-Treasurer & Asst. Secretary Treasurer
 - (B) The Executive shall consist of President, Chairman Capt. & Secretary
 - (C) The Selection committee shall consist of Capt., Secretary & Vice Captains. Capt. to have casting vote. Chairman & 1 other member
 - (D) Selectors to select teams one week previous to match or matches
 - (E) Teams selected to be published in paper & a copy to be placed on clubs notice board
 - (F) Members unavailable to let selectors know as soon as possible if unavailable. Where possible, ^{the} member unavailable will let the reserve, who will be named along with team, that she or he will be needed to play
- 3
 - (A) Club membership to be limited to 50 players
 - (B) Players wishing to join club will make application in writing to the club Secretary. Such application to be discussed at a General Meeting of the Club
 - (C) Should any member act in a disorderly manner at home court or on a visiting court the Executive shall have power to deal accordingly
 - (D) The Captains word shall be final on the court without comment from members except at meetings
 - (E) All grievances to be aired at Meetings
- 4
 - A Subscriptions to be £-10.0 a year for men & £-15.0 for ladies. Subscriptions to be payable yearly in advance. Any member unfortunatly after the 31st May, may not be eligible to be picked in any of the clubs teams.
 - B. A court levy of 10/- per gent player will apply to those, who are ~~not~~ ^{not} on the court roster for doing up the courts. In addition a ~~court~~ ^{ball} fee of 6/- per player per day will be charged.
- 5 General meetings to be held during the second week of each month. A notice of the meeting will be placed on the Clubs notice board advising of the particular night. Annual General

meeting to be held during the last week in January of each year. The financial year of the club will start on the 1st Feb each year.

- 6 (A) Two new ^{first class} balls to be purchased each week for each court
(B) Two balls to be left at ~~the court~~ each court for the convenience of players
- 7 Secretary to arrange all matches & conveyance when visiting. Collect all subscriptions & issue receipts for same. Purchase new balls. Present detailed balance sheet each meeting. Chairman & Secretary to sign minutes, inward & outward correspondence & Balance sheet, when passed at each meeting
- 8 Club to open Bank account which can be operated on by any two of the following - Chairman Secretary & Ladies *Pro Vice* Capt.
- 9 Capt or in his absence the Vice Capt to collect daily ball fees.
- 10 Auditor to examine books at the end of each year & to report at Clubs Annual Meeting each year.
- 11 A Quorum shall consist of 5 members.
- 12 (A) The Club to carry ~~to~~ Junior Members.
(B) A Junior member can attend meetings but not hold official positions
(C) Junior rates on joining to be ^{£1.10.0} £10.0 for boys: £7.6 for girls. These rates will apply for two years from the time of joining & then if the member is working full Senior rates will apply. Otherwise the young joining rates will apply until with an age limit of 17 years
- 13 All ~~resignation~~ resignations to be in writing otherwise a clearance to play with another club will not be granted.
